Summarized **MINUTES** from a regular Board of Commissioners meeting of Scott Valley Fire Protection District, Greenview, California. The meeting was held on Tuesday November 10, 2020 and was opened at 5:00p.m. by Chair Larry Alexander. Present were Vice Chair James C. Roseman, and board members Kathleen Williams and Kevin Hullquist, plus Chief Paul Buchter and Administrative Officer Nancy Salucci. Jay Akerman was absent.

Chief Buchter is forming an internal committee with core individuals to oversee equipment and personnel.

RESOLUTION re Greenview Station lot line adjustment; authorizing Chief to represent SVFPD

A resolution was passed to allow Chief Paul Buchter to represent Scott Valley Fire Protection District with the Siskiyou County Building Department in the process of doing a lot line adjustment at SVFPD-owned parcels on Maple and Main Streets, Greenview, CA, tax lots 024-510-140 and 024-510-220.

New firefighter applications, deletions from roster

Brian Paul has moved to Montague—remove from roster. Justin Frew and Dave Donahue are both back on the roster. There are currently three applications pending: Callahan, Rogers, and Kramer.

Update on status of "chaser' vehicle for strike team participation_American Diesel said they have been too busy to work on our Ford. They recommended installing a new engine. Chief Buchter will discuss the potential cost and a timeline with them.

Training/Safety/Injury and Illness Prevention Program monthly report Trainer Mike Wilson will focus on basic wildland training for now and will soon transition to structure fire training. Assistant Chief Frick handled a member's workers' comp claim for poison oak contacted at a strike team fire. Safety topics were how to "conduct engine inspections so as to not catch an engine on fire" and to "not get in front of a fire."

Continuing/New business

- Veronica Rasmussen at QVIR would like her team to participate in our training. Salucci suggested QVIR contribute financially to the instructor's fees.
- Chief Buchter will oversee the completion of the Kellems Lane project.
- We have approximately \$35,000 in equipment grants for which Chief Buchter will start making purchases.
- Scott River Station is completely vacated and the sign is removed. Tender 1537 will hopefully be housed at Captain Pearson's. Alternatively, it can be winterized and stored outside of the Greenview Station.

SVFPD Minutes November 10, 2020

Acting Chief Scott Frick is now retired.

After the meeting, Frick was honored by the Board and SVFPD personnel for his twenty years of service as a volunteer firefighter, EMT, Captain, Assistant Chief, and Acting Chief.

Frick offered to apply for a position on the SVFPD Board of Commissioners when the next position becomes available.
